Terms & Conditions

Assignment and Use of Event Space: ThemFive will assign vendor spaces, based on vendor requests, at our discretion, on a first come first picked spot basis. Vendors acknowledge that ThemFive reserves the right to refuse any vendor for any reason. ThemFive also reserves the right to reassign vendor spacing or to alter event layout at any time if the layout creates a problem for attendees, performers, other vendors, sponsors, park regulations, or ThemFive.

Vendors agree that ThemFive will not be held liable for any reactions, illnesses, deaths, or other injuries; physical, mental, spiritual, or emotional that may result from the usage of any product. All liability falls on the below signed.

Care of Park and Equipment: Exhibitors or entourage must not injure, deface, or damage the property of park, ThemFive, or any rental company providing equipment for this event. If such damage occurs the signee is liable to the owner of the damaged equipment.

Liability: Notwithstanding anything in the agreement to the contrary, each party will be liable for the negligent, or willful acts or omissions of its employees, officers, agents, directors, invitees, contractors, or others acting on behalf or with its authority, and shall indemnify the other party for any liability arising there from. Exhibitors further agree to indemnify and hold ThemFive and the owners and lessors of park, harmless from claims by the exhibitor's agents or employees or by any other persons arising out of any act or omission connected with the exhibitor's participation in the event whether negligent or not. ThemFive shall not be responsible for the security of exhibitor's equipment or its proprietary information, and the exhibitor shall have full responsibility for any theft or other loss including any subrogation claims by its insurer. It is the responsibility of the exhibitor to maintain proper insurance coverage for its property and liability. None of the event coordinators shall be liable to any exhibitor for any loss, damage, harm or injury to the person, property or business or any of its visitors, officers, agents, or other representatives, resulting from

theft, fire, earthquake, water, unavailability of the facility or intermediate staging facilities, insufficient participation, accident, or any other reason in connection with the event or planning meetings demonstration, or stagings.

Facility Rules: Vendors shall comply with all rules and regulations of ThemFive and Aggie Park.

ThemFive Rules:

ThemFive rules are as follows:

- We reserve the right to refuse any vendor for any reason.
- All vendor fees must be paid in full before any set up begins by that vendor.
- Vendors paying the day of the show must report to the park no later than two hours before the start of the show (11 o'clock)
- ThemFive will assign vendor spacing on a first come first serve basis- ThemFive will be at the park at 9am, vendors can report as early as this to pick a space and begin set-up if prepared
- No electrical cords, outlets, or generators will be provided by ThemFive
- No tables or chairs will be provided by ThemFive
- Park closes at 6 and the festival is over at that time. Clean-up will commence until nightfall
